Sir,

I am directed to refer to IBDF's communication dated 16<sup>th</sup> May, 2023 on the above mentioned subject and to convey the approval of the competent authority in the Ministry for registration of Digital Media Content Regulatory Council (DMCRC) as the Level-II Self Regulatory Body for publisher of online curated content as per rule 12 of Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021.

2. It is hereby informed that DMCRC has been registered as the Self-regulatory body with the following member publishers of online curated content:
